- d. On April 26th, I attended the NBISG meeting in Eel Ground. I am working on a final draft of the Sport Technical Package.
- e. On April 28th, I participated on the Aboriginal Sport Circle's NAIG Domestic Allocations conference call. Based on the 2011 census NB has been allocated 125 participants for the 2017 NAIG. Allocations are attached.
- f. On April 29th, I participated in the new Network for Ethical Sport and Recreation Concussion and Ethics workgroups. Purpose and Objective of this network: 1) Bring like-minded stakeholders together, with the goal to clearly define agreed upon actions (decided upon by the group) 2) Collaboration and sharing are the words of the day for this network, to share best practices, avoid duplication, de-silo our work 3) identify needs/gaps and work towards filling them and establish a mechanism of measuring work accomplished 4) not to create new or more work (unless agreed upon by the group), work within the parameters of current work load and areas of responsibility of individual stakeholders 5) to include non-traditional but relevant stakeholders from outside of the sport and recreation system.
